Re: Qualified institutions placement of equity shares of face value of ₹ 2 each (the "Equity Shares") by the Company under the provisions of Chapter VI of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the "SEBI ICDR Regulations"), and Sections 42 and 62 of the Companies Act, 2013 (including the rules made thereunder), as amended (the "Issue").

In continuation of our earlier letter dated January 19, 2024 on the captioned subject, we wish to inform you that, in respect of the Issue, the Fund Raising Committee at its meeting held today, i.e., January 19, 2024, approved the issue and allotment of 14,662,756 Equity Shares to 43 qualified institutional buyers at the issue price of ₹341 per Equity Share, i.e. at a premium of ₹339 per Equity Share, (which includes a discount of ₹17.30 per Equity Share, being equivalent to a discount of 4.83% of the floor price of ₹358.30 per Equity Share, as determined in terms of the SEBI ICDR Regulations), aggregating to ₹500.00 Crores (Rupees Five Hundred Crores Only), pursuant to the Issue.

Further, find attached herewith the list of allottees who have been allotted more than 5% of the Equity Shares offered in the Issue, marked as **Annexure 1**. The shareholding pattern of the Company, before and after the Issue, will be submitted along with the listing application in the format specified in Regulation 31 of the SEBI Listing Regulations.

The Issue opened on January 15, 2024 and closed on January 19, 2024 and the same was intimated to you through our letters dated January 15, 2024 and January 19, 2024, respectively.

Pursuant to the allotment of Equity Shares in the Issue, the paid-up equity share capital of the Company stands increased from ₹193,447,342/-, comprising of 96,723,671 Equity Shares to ₹222,772,854/-, comprising of 111,386,427 Equity Shares.

The meeting of the Fund Raising Committee commenced at 11.20 p.m. and concluded at 11.30 p.m.
